City Funding for BLESS Summer Nature Centre

The City of St. Albert has agreed to continue it's partnership with BLESS by funding the children's summer environmental education program.

BLESS President Miles Constable made a presentation March 19 to St Albert City Council for their financial support for the BLESS Summer Nature Centre environmental education program. Their reception of the proposal was positive and warm, supporting it in full for 2007. Following years may be funded through the proposed St Albert Environmental Projects grant.

This is the first time that BLESS has requested City support for the program other than for the provision of the RCMP log cabin as a venue. That is supplied for the cost of the utilities.

The Summer Nature Centre should open the first week of July running Tuesday to Saturday mornings and afternoons. Come down and check it out with the kids, register them for the Young Naturalists Program, or just play a few games and look at critters, etc.



Webcam funded by Province

Mr. John Kristensen, Assistant Deputy Minister of the Parks, Conservation, Recreation and Sports Division of Alberta Tourism, Parks, Recreation and Culture sent us a check for \$10,000 to help pay for our web camera project.

This is a most important start to our implementation of the NAIT feasibility study for the installation of a cutting edge webcam in a rugged, remote location. Our next steps are to get a firm quote from a prospective supplier of a remote-capable, solar powered webcam, look to the infrastructure needed for installation and to start on finding an internet link point within line-of-sight to the camera. While it won't buy us a Cadillac system, it is a very positive start.

Upgrades and repairs

City and provincial crews have been busy out at the BLESS Platform.

Contractors hired by the City of St. Albert have been out repairing the BLESS platform, that is actually owned by the City. Over the years it became apparent that the platform was sagging and pulling apart. With some investigation it became apparent that one of the supports under the platform had slipped off of a brace. The City effected temporary repairs last summer until an engineer could look it over and determine what exactly was wrong with it, and why the support had slipped. This winter the City hired a firm to do a better repair based on the engineer's study. It seems that one of the large posts is sinking, not an unusual thing to have happen as the soil there is very soft. The solution was to jack up part of the platform until it was level and to install surface braces to spread the load of the platform over a wider area.

RAMSAR Nomination project

After a winter hiatus we have re-initiated our RAMSAR nomination process. We received approval for the project last year from the Minister of Environment and from the Canadian Wildlife Service and started to put together the lengthy report to support the nomination. Several members have worked on the project and it is progressing well, but we can always use more hands.

Last July, BLESS received approval to proceed with the Ramsar nomination from David Coutts, then minister of Sustainable Resouce Development, who indicated the nomination would support provincial and other conservation initiatives and programs underway.

Our task now is to complete the Ramsar Information Sheet (RIS) required for the nomination. There are 34 information blocks for the RIS that must be completed. When finished, the RIS will describe virtually every facet of the natural area.

A listing of titles for each information block along with the status of research and writing efforts to date is included below. We are fortunate to have access to invaluable research material in the form of the Big Lake Management Plan Phase 1 Report and associated Literature Review produced in 2002 for Alberta Community Development Parks and Protected Areas by Amec and Dr. Richard Thomas. The literature review provides a thorough list of documents relating to Big Lake that have been published in the past and summaries of key points contained within each document.

If you are interested in helping with the Ramsar nomination, please review the list below and send a note back indicating the topics you might wish to research and write about. Topics annotated *** remain to be started. An outline of information expected for each topic will be provided. Research material that is on hand will be made available for download as will assistance in tracking down additional required research material that might be identified.

I hope you can help with this worthwhile project to obtain further status for Big Lake and Lois Hole Provincial Park. We would be pleased to answer any questions you might have about this initiative and the work to be done.

Big Lake Area Structure Plan

The City of Edmonton planning department is holding a public meeting to discuss a proposed amendment to the Big Lake Area Structure Plan, a 16 year old planning document that is being resurrected to enable a new housing development to go in near the shores of Big Lake in close proximity to Lois Hole Centennial Provincial Park.

City planners will be there to gather your input to pass along to Edmonton City Council to consider when making the decision to approve the subdivision. The developer (United Developments) and its partner contractor (Stantec) will present their plans at the meeting and answer questions.


The BLESS Board of Directors will be formulating a response to the proposed development that we will send to the planning department as well as directly to Edmonton councillors and Mayor Mandel. We actively solicit your input into our submission.


City planners typically record the number of people who attend such public meetings and their affiliation to gauge the degree of support for submissions and the concerns expressed therein. This information is also passed along to city councillors who use it for the same purpose.

The meeting will be a good chance to get a sense of what is being proposed for the south shore of the province's newest provincial park. In the relatively near future we will see more than 28,000 people and some 8,000 dwelling units clustered on the south shore of Big Lake. Preliminary maps showing the location and concept of the first part of the development are posted at

The public meeting will be held at the Glendale Golf and Country Club, 12420 -199 Street on Thursday, April 12, 2007 beginning at 7:00 pm. It is important that





salinity, electrical conductivity, alkalinity,	
ammonia, nitrate, nitrite, phosphate,	
cyanide, sulphate, and silica. This is a	
typical suite of parameters that can tell us a	
lot about the general quality of the water in	
Big Lake. In March we also took a sample	
from the west bay through the ice. The	
water was devoid of oxygen and smelled	
strongly of hydrogen sulphide (rotten	
eggs). It isn't likely that it would support	
any aquatic life but bacteria.	
A report on the first season of sampling	
will be prepared by the end of May and	
submitted to the Alberta Ecotrust	
Community Grant program.
